SUBMISSION

Articles should be submitted in text format (rtf, doc) electronically (via e-mail, with the title “Article” written as the subject of the e-mail) to: politicalreview@uni.wroc.pl

English language

All submitted manuscripts should be written in grammatically correct English. The *PPSR* have the right to reject an article which does not fulfil the linguistic requirements, as well as to return it to the author for revision. Only articles submitted in English are accepted by the journal committee. However, full proofreading of all the accepted articles is provided without any additional charge.

All submitted articles should conform to the following **editorial rules**:

Notes of author(s)

Abstract

Keywords (3-6)

Formatting:

font: 12 point, Times New Roman;

single spaced; interline interval 1,5; margins: left and right 2,5;

all included pictures, tables and charts should be editable, and be provided with a concise legend;

please do not number pages;

justification: justify both sides;

title: italics; foreign words: italics;

citations: vertical commas “...” for in-text citations; breaks in citations [...]; citations inside other citations “...>>...<<...”;

initial letters of mentioned/ quoted persons’ names preceding their surnames;

indicate a part of the text by italics or wide letter spacing if italics has been already used;

please do not use bold font;

please avoid using abbreviations;

for all in-text-citations a Harvard style should be followed;

please do not use an automatic word division option;

Title page: the title (capitalized first letters, italics), names of an author/ authors, e-mail addresses, affiliation;

Notes of authors: biographical data (up to 100 words) and: affiliation, address, e-mail address

Abstract: up to 300 words, brief summary of the main aims, research questions, methods, results and conclusions;

Main text: text volume (with references) should not exceed 40 000 keystrokes (including spaces) for articles, 10 000 for book reviews;

In-text citations:

Please use citations in the text rather than footnotes. Cite the author, year of publication and, when appropriate, page numbers, e.g. (Czaja 2008, 50-52).

For many texts by many authors, separate authors by semicolons (Czaja 2008; Tyrała 2011).

References:

A book:

Author's / Authors' surname(s) initials (Year). *Title*. Edition. City of publication: Publisher.

Part of a book (e.g. a chapter):

Author's / Authors' surname(s) and initials (Year). Title of a part or chapter. In: Author's/ Authors' surname(s) and initials ed(s). *Title of a book*. Edition. City of publication: Publisher, page numbers.

Journal articles:

Author's / Authors' surname(s) and initials (Year). 'Title'. *Title of the journal*. Vol., No., page numbers.

E-journal articles:

Author's / Authors' surname(s) and initials (Year). 'Title'. *Title of the journal* [online]. Vol., No., page numbers (if given). Available at <full address> [Accessed on Date of access].

E- Book:

Author's / Authors' surname(s) and initials (Year). *Title* [online]. Edition. City of publishing: Publisher. Available at <full address> [Accessed on Date of access].

Internet website:

Author's / Authors' name(s) and initials (Year). *Title* [online]. City of publishing: Institution (if given). Available at <website address> [Accessed on: Date of access].

PUBLISHING POLICY

Publication ethics

The *PPSR* care about the quality of published articles and intellectual property rights. The journal committee will not accept any forms of unfair acting, such as: *ghost-writing* (i.e. the participation of other persons who are not mentioned as the authors of a submitted manuscript), *guest-authorship* (the authorship of a piece by persons who in fact did not contribute to the work, and whose name is added purely for "prestige") or *plagiarism*. All sources and authors should be clearly stated in accordance with the *PPSR*'s editorial rules. A signed author's statement should be attached to each submitted article either electronically (i.e. scanned version) or via post.

Information for Authors:

All authors are responsible for articles they submit, i.e. for the quality, the proper use of English language, as well as the accuracy and completeness of their references and citations. The *PPSR* publisher reserves the right to reject or edit submitted articles, as well as to recommend revisions and withdraw the articles that have not included suggested revisions.

The authors will be informed (by e-mail) about:

1) Submission of their manuscripts to the referees – within 50 days

All articles are peer-reviewed in a double-blind review process. The committee is responsible for forwarding an article to two independent referees in an anonymous manner. The secretary informs the authors about the submission of their articles to the referees.

2) The main conclusion from referees' reports - within 6 months

Within 6 months of an article's submission to two independent referees, the main report conclusions are passed on to the corresponding author. Following the review process,

- a) an article is accepted for the publication as it stands,
- b) an article requires minor/ advanced revisions, e.g. with regard to the language, used data, contents or technical/ formal aspects – an author is asked to revise and resubmit the article,
- c) an article is rejected and will not be published in the *PPSR*.

3) Accepted papers will be published within 24 months after accepting the manuscript.
